PEBBLE CREEK ANNOUNCES CLOSING OF PRIVATE PLACEMENT

Vancouver, British Columbia – April 9, 2009 – Pebble Creek Mining Ltd. (the “Company” or “Pebble Creek”) announces that it has completed a second and final closing of a non-brokered private placement (the “Private Placement”) previously announced on February 23, 2009 by issuing a further 269,862 units (“Units”) at a price of \$0.07 per Unit for gross proceeds of \$18,890, bringing the total gross proceeds from the Private Placement to \$78,390.

Each Unit consisted of one common share of the Company and one-half of one common share purchase warrant (“Warrant”). Each whole Warrant issued upon the final closing entitles the holder to purchase one common share of the Company at a price of \$0.15 until April 9, 2011.

The Private Placement is subject to the TSX Venture Exchange’s approval.

The common shares and Warrants comprising the Units issued pursuant to the final closing, and the common shares underlying these Warrants, are subject to a hold period in Canada which expires on August 10, 2009.

The net proceeds from the Private Placement will be used for exploration and development of the Company’s projects and for working capital.

Pebble Creek has been exploring in India since 1995 and has built up a technical and business infrastructure. The Company’s main project is the Askot deposit of copper, zinc, lead, silver and gold in Uttarakhand state. The Indian Ministry of Mines and the Uttarakhand government have approved the Company’s Mining Lease. Environmental and Forest Clearances are in progress, the last remaining major permits before the Mining Lease is executed.
